INTRODUCTION

STYCCOCLEAN C141 is a general purpose cleaner for removing contaminants such as grease, oil, etc. from the back of floorcoverings and accessories prior to installation. It also assists in the removal of some adhesives from the surface of carpets and floorcoverings.

STYCCOCLEAN C141 can be used on most types of carpets and floorcoverings, covings and nosings etc made of linoleum, rubber, vinyl and metal. It can also be used for cleaning tools after use.

APPLICATION

Cleaning floorcoverings and accessories

Dampen a cloth with the cleaner and then rub the area to be cleaned until all the contamination has been removed. Take care not to use too much cleaner on rubber, linoleum, vinyl floorcoverings or accessories as this may cause damage. When cleaning the back of floorcoverings or accessories, allow all traces of the cleaner to evaporate before commencing installation, alternatively wipe dry to remove all the cleaner residues.

Removing adhesive from carpet

Apply the cleaner gently with a cloth until the adhesive has been softened then remove the adhesive using a small stiff bristle brush. Take care not to rub softened adhesive residues further into the carpet pile.

PRECAUTIONS

The cleaner may damage floorcoverings if left in contact too long. Test before use to ensure that the cleaner does not damage the material or affect the colour stability. May affect some plastics, check for suitability prior to use.

Do not use on asphalt, tarmac or other materials which may be sensitive to this cleaner. Do not allow the cleaner to penetrate the joints between floor tiles. Do not apply onto a hot surface or any incandescent material.

TOOLS

Clean absorbent white cloth. Small stiff bristle brush.

STORAGE

Store between 5°C and 30°C. Protect from frost.
